Attached is the Alaska Performance Scholarship (APS) Accelerated Program Enrollment Verification Form which is required to document eligibility for APS funding on an accelerated schedule in accordance with Alaska Regulation 20 AAC 16.220 (e).

Because using the APS on an accelerated basis reduces your terms of eligibility, to ensure your decision is an informed one, you are required to document your plan for completing the enrollment requirements on the Accelerated Enrollment Verification Form. Prior to completing this form, we also urge you to speak with your academic advisor to determine whether attempting an accelerated course load is in your best interest.

If you do not intend to meet the enrollment requirements necessary for accelerated status, you do not need to take any action and your APS award will be scheduled based on regular enrollment.

After completing and signing the enclosed form, please submit it to ACPE at the above address so that your APS award can be scheduled for acceleration. Please be advised that unless we receive a completed and signed form, your APS award will be administered on a regular enrollment basis.

Alaska Performance Scholarship (APS) Accelerated Enrollment Verification Form

This form is to attest to ACPE and your institution's financial aid office that your enrollment status will qualify you to receive APS funding on an accelerated schedule. Please complete and sign the form and return it to ACPE@alaska.gov, or to the above address.

An APS recipient may request scholarship funds on an accelerated basis whereby the standard four year/eight semesters (or its equivalent) of funding is compressed into a three year/six semester timeframe. An APS recipient seeking an accelerated award must meet the following credit completion requirements:

- 1. In the first year of enrollment, complete 36 semester hours (or the equivalent); and,
- 2. In each of the next **two years** of enrollment, complete **45** semester hours.

In addition to the accelerated credit completion requirements, all APS recipients must maintain a cumulative grade point average (GPA) of 2.5 on a 4.0 scale.
