#### What is WICHE?

- An interstate compact formed by the Western Governors in 1951
- Congressional action signed in 1953 by President Dwight D. Eisenhower

#### The Western Regional Education



Entered into by and between the States and Territories signatory benete, to provide acceptable and efficient educational facilities to meet the needs of the Western Region of the United States of America.

I WHEREAS, the future of this Nation and of the Western States is dependent upon the quality of the education of its youth; and

WHEREAS, many of the Western States individually do not have sufficient numbers of potential students to warrant the establishment and maintenance within their borders of adequate facilities in all of the essential fields of technical professional, and graduate training, nor do all the states have the financial ability to furnish within their borders institutions capable of providing acceptable standards of training in all of the fields mentioned above; and

WHEREAS, it is believed that the Western States, or groups of such states within the Region, cooperatively can provide acceptable and efficient educational facilities to meet the needs of the Region and of the students thereof.

Now, therefore, the States of Arizona, California, Colorado, Idaho, Montana, Nevada, New Mexico, Oregon, Utah, Washington, and Wyoming, and the Territories of Alaska and Hawasi do hereby Covenant and agree as

II Each of the compacting states and territories pledges to each of the other compacting states and territories faithful cooperation in carrying out all the purposes of this Compact.

III The compacting states and territories hereby create the Western Interstate Commission for Higher Education, hereinafter called the Commission. Said Commission shall be a body corporate of each compacting state and territory and an agency thereof. The Commission shall have all the powers and duties set forth herein, including the power to sue and be sued, and such additional powers as may be conferred upon it by subsequent action of the respective legislatures of the compacting states and territories.

IV The Commission shall consist of three resident members from each compacting state or territory. At all times one Commissioner form each compacting state or territory shall be an educator engaged in the field of higher education in the state or territory from which he is appointed.

The Commissioners from each state and territory shall be appointed by the Governor thereof as provided by law in such state or territory from which he shall have been appointed.

The terms of each Commissioner shall be four years: Provided, however, that the first three Commissioners shall be appointed as follows; one for two years, one for three years, and one for four years. Each Commissioner shall hold office until his successor shall be appointed and qualified. If any office becomes yearned for any reason, the Governor shall appoint a Commissioner to fill the office for the remainder of the unexpired term.

V Any business transacted at any meeting of the Commission must be by affirmative vote of a majority of the whole number of compacting states and territories.



## **Professional Student Exchange Program (PSEP)**

- 10 healthcare degree fields
- Savings varies (\$9K \$35K),
   depending on degree and program
- 11 states/territories fund PSEP students through WICHE

#### **How PSEP Works**

- ► Applicant applies to home state office for "certification" and applies to cooperating programs in their field.
- ► State determines fields to be funded, and number of seats by field.
- Students are selected for funding (sometimes rankings are used).
- ► States provide a "support fee" to reduce student's tuition (public and privates participate).
- WICHE administers funding on behalf of its PSEP states; also monitors student progress and graduation.
- States can use PSEP as a "return-for-service" workforce building provision.





# **State and Territory Investment**




#### **PSEP Graduate Return Rates, AY 2012-22**



Wyoming is listed as an honor state for this cycle because less than half of its graduates in the current cycle have a contractual service payback. It will be reclassified as a contractual payback state in the next reporting cycle, in  $\approx$  2027.

## **Thoughts for Consideration**

- Current PSEP strategy isn't as targeted as it could be; there is little incentive guiding students toward high-need fields.
- ► PSEP could be an effective workforce development tool that is part of Alaska's overall strategy.
  - WICHE recommends basing decisions on workforce projections.
- Alaska may want to consider alternatives to the loan program or supplemental strategies.
  - Some or all fields could be shifted from a loan program to an appropriation.
  - The state could consider loan forgiveness on high needs fields.
- ► WICHE is open to considering new fields if there is a need.
