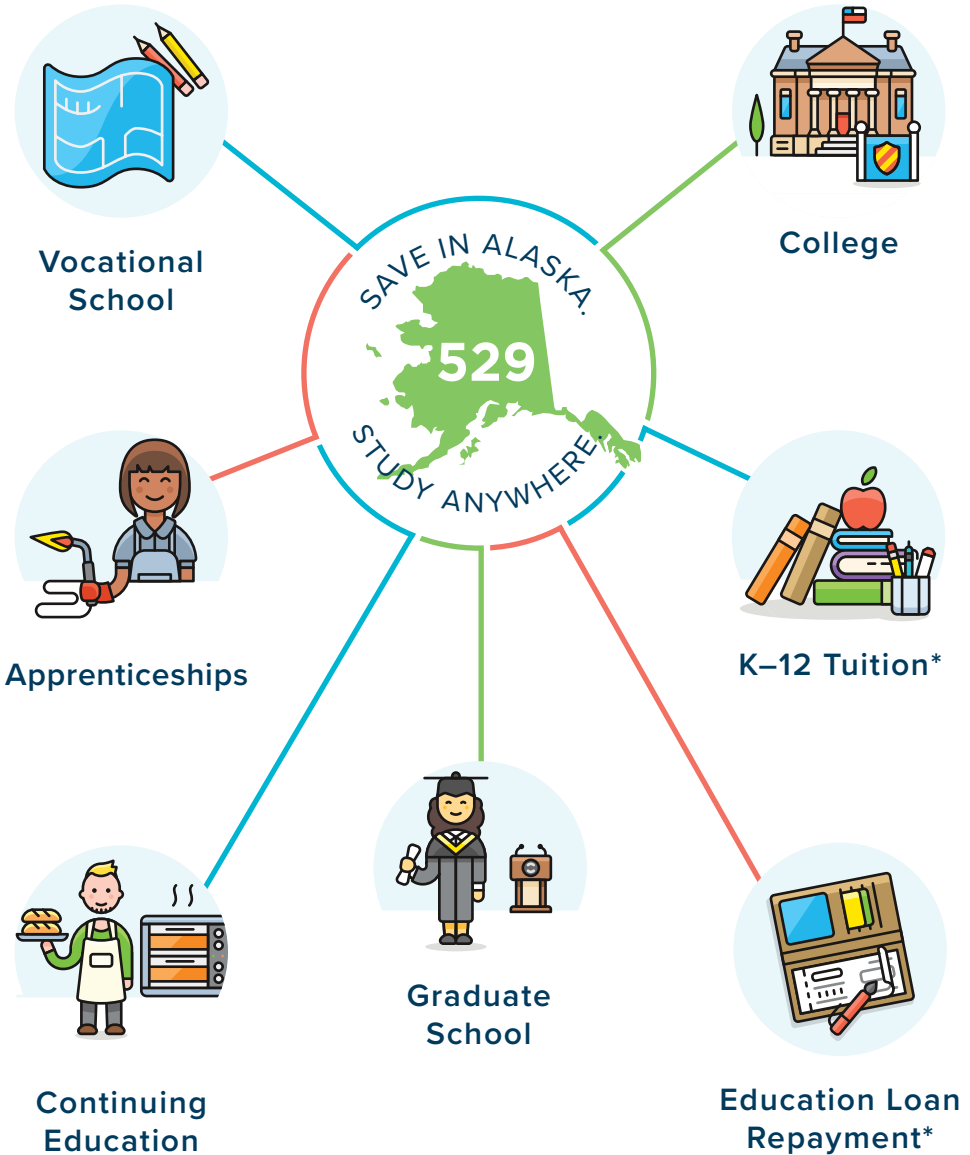

# ONE PLAN, MANY PATHS

You can use your Alaska 529 account for education-related expenses such as tuition, fees, room and board, books, supplies, and computer equipment,\* both in and out of state, wherever your loved one's path takes them.

## REASONS TO CONSIDER

# ALASKA 529

- Any earnings grow tax-deferred. Qualified distributions are exempt from federal taxes and can be used in or out of state.
- You can choose from a range of professionally managed investment options, including the University of Alaska Portfolio, which carries a tuition-value guarantee.
- Anyone can open or contribute to an account, including grandparents, family members, and friends.
- You can contribute half of a PFD by answering “**Yes**” to the Alaska 529 question on the PFD application each year. Full PFD contributions are also available via direct deposit.
- Participants with an active account for two or more years may be eligible for resident tuition rates at the University of Alaska regardless of residency.
